We note that the internal auditor has not provided a conclusion on internal control objective O in respect of trust funds. The Annual Internal Audit Report will inform the authority's response to Assertions 2 and 6 in the annual governance statement. As a result, the authority must ensure that assurance that has not been provided via these control objectives has been sought
